San Antonio College. Submit form and required attachments to the Office of Admissions and Records at Mt. SAC (Student Services Building, 1st Floor).

| <input type="checkbox"/> | I am a spouse or child using benefits under the Marine Gunnery Sergeant John David Fry Scholarship who lives in the state in which the institution of higher learning is located and am enrolling in the school within three years of the Service member’s death in the line of duty following a period of active duty service of 90 days or more. | <ul style="list-style-type: none"> • Copy of Certificate of Eligibility for Chapter 33 – Fry Scholarship |

Note: Individuals who initially meet the requirements above will maintain “covered individual” status as long as they remain continuously enrolled at the same institution of higher learning, even if they are outside the 3-year window or enroll in multiple programs.
