From March 20, 2020 to present, all services and activities have been modified to be conducted virtually via Zoom, phone, and in-person. Services provided include individualized and group advising, career development, time management, academic honesty, note and test-taking strategies, financial aid information and assistance, emotional intelligence, empowerment, college success, study skills, and financial literacy. The ACES Program has been working closely with the Mt. SAC's Career Center and Student Success for Education and Employment Development (SSEED) program to leverage a plan of operation as a tool engagement for students to find paid work opportunities on campus that are related to their educational and career goals. Following the proposed plan of operation, ACES students have embarked on their journey through college with a comprehensive suite of services aimed at helping them enter the right pathway towards their professional and career goals through program activities including multiple measures assessment, training on financial literacy and the costs and benefits of college attendance. The activities and workshops we enacted are as follows: Virtual College Tours, Transfer information and application assistance, Financial Literacy, FAFSA information and application assistance, and ACES group and individual monthly check-ins. The students' individualized pathway is clarified and reinforced through the use of comprehensive educational plans, counseling interventions and linkages to employment opportunities. The ACES Program has monitored student progress to ensure they stay on the path with the help from program activities such as mentoring, counseling, and workshops. Providing online services has increased flexibility to access services and resources, allowing students the affordability to continue to seek additional opportunities as well as minimizing cost and/or loss as a result of accessing services.

The ACES project has offered participating students a variety of financial literacy workshops on student loans, budgeting/debt awareness, financial planning when transferring to a university, and other topics to foster knowledge and promote the development of lifelong personal skills. Once accepted into the program, each student has gone through a day long orientation which included a financial literacy component that will help understand how to finance a college education. In coordination with other programs on campus aiming to help students develop these important skills, ACES directed students to an online platform, ACES Hub. Through the ACES Hub students can make counseling appointments, career center information, graduation and transfer updates, learn about workshops provided by the ACES Program and access online modules on financial literacy developed through the Title V – Developing Hispanic Serving Institutions project. These modules have reinforced strategies on how to be fiscally responsible citizens. ACES has collaborated with the campus Mountie Money Management Center to engage students in financial literacy by disseminating information at the ACES student orientation each semester.
